

**FAIR SHARE ANNUAL CONTRIBUTION AND CAPITAL PLEDGE SCHEDULE**

**AGES 36 – 39**

**July 1, 2008 - June 30, 2009**

The Congregation is a dynamic community of its members, built on a special sense of belonging and sharing. In a cooperative commitment, each member provides a Fair Share of the Temple's support. Annual contribution depends upon financial ability, based on total household income received from all sources, (earned and unearned). The schedule below indicates the Annual Contribution and Capital Pledge for each income level.

To help new members ages 36 thru 39, transition to Fair Share, the first four (4) years of annual contribution will be billed as follows: (yearly Capital Pledge to be billed per schedule below)
