## TRANSITIONAL SCHEDULE

For members age 36 – 39 or

35 and under who have children enrolled in WHC's Religious School (RS) or Early Childhood Center (ECC)

To help young members transition into the Annual Contribution Schedule of our Fair Share Membership (see below), we have implemented a stepped increase in dues over four (4) years.

First Year25% of AC (not less than \$900 if child enrolled in ECC; not less than \$700 if enrolled in RS)Second Year50% of AC (not less than \$900 if child enrolled in ECC; not less than \$700 if enrolled in RS)Third Year75% of AC (not less than \$900 if child enrolled in ECC; not less than \$700 if enrolled in RS)Fourth Year100% of Annual Contribution
